Dear Mr. Melcher:

This letter is in response to a letter from Ms. Sheanna Steingass Marine Mammal Program Leader, Oregon Department of Fish and Wildlife (ODFW), dated May 21, 2020, requesting, with supporting data, that the National Marine Fisheries Service (NMFS) amend Appendix 1 of the 2018 Authorization to add two (2) California sea lions to the list of “predatory” sea lions that are authorized for lethal removal under section 120 of the Marine Mammal Protection Act.

Ms. Steingass’s letter provided information collected by ODFW on two individually identifiable California sea lions observed in the vicinity of Willamette Falls. We reviewed the information and concur that these animals meet the criteria outlined in Condition 1 of the Authorization. Accordingly, Appendix 1 has been amended to include these additional California sea lions, and your agency may therefore permanently remove these animals. A copy of Appendix 1 as amended is enclosed.

Removal Date = The date the animal was permanently removed (killed, transferred to captivity, found dead).
