I hereby delegate to you the authority to administer the Letters of Agreement (LOA) for response to marine mammal strandings.


#### **BACKGROUND**

Secretary of Commerce (whose functions under the MMPA have been delegated to the NOAA Assistant Administrator (AA) for Fisheries) with the authority to enter into agreements with any person to take marine mammals under MMPA section 109(h)(1) in response to a stranding. These agreements are commonly referred to as Letters of Agreement (LOAs). They are also referred to as LOAs in the legislative history of the MMPA. Non-governmental organizations and persons participating in the National Marine Fisheries Service (NOAA Fisheries), Marine Mammal Stranding Network, are required to have a valid LOA signed by NOAA Fisheries. This authority should be officially delegated from the NOAA AA for Fisheries to the Regional Administrators and filed into the NOAA Delegations of Authority and other Organization Handbook Issuances databases.

This delegation of authority is consistent with the organization of NOAA Fisheries' Marine Mammal Health and Stranding Response Program, which has a National Coordinator to provide program guidance and consistency for marine mammal stranding response and rehabilitation, and six regional Stranding Response Coordinators who oversee regional marine mammal stranding networks that respond to stranding events.
